Southern Cayuga Central Schools 315-364-7211 Southern Cayuga Central School District residents will vote on a \$19,914,840 budget proposal for the 2024-2025 school year on Tuesday, May 21, from 7 am to 9 pm in the District Office. Voters will also select from three candidates for two open seats on the Board of Education, consider additional propositions including the purchase of school buses/student transportation vehicles, and an increase in taxpayer support for the Aurora Free Library and the Hazard Library Association.

Budget Proposition

The Board of Education is proposing a budget of \$19,914,840 that includes a 3 percent tax levy increase, which is a 0.35 percent expense increase over last year's budget amount. This budget embodies a balanced approach by proposing to use approximately \$741,000 of fund balance/savings, eliminating 11 positions, and instituting a tax increase for the coming year. Despite the loss of federal grant funding and anticipating significant cost escalators such as contractual labor, increased special education tuitions, rising electricity expenses, and healthcare costs, we've diligently worked to contain these expenses, aiming to keep the overall budget increase minimal. Thankfully, the district is in a position to leverage its fund balance to cover the loss of the annual increase in foundation aid, that typically has been received year after year, due to the district's fiduciary restraint over the past 8 years.

Transportation Proposition

Voters will be asked to approve a proposition for student transportation: purchase of (1) small wheelchair accessible bus; (1) 66-passenger bus; and (1) mini-van/SUV for student transport. This continues the annual bus/vehicle replacement plan and maximizes both state aid and trade-in value by replacing vehicles on a consistent 5-year plan. This process also allows the district to ensure a safe and reliable fleet to transport our students.

Local Library Propositions

The Aurora Free Library and Hazard Library Association are asking voters to consider an increase of \$5,000 each, for continued support and maintenance. There will be two separate propositions for your consideration.

Meet the Candidates and the Budget Hearing are scheduled for May 13, at 6:00 PM in the High School Auditorium. Thank you to the residents of Southern Cayuga for your continued support.



The state requires school districts to present their annual budgets in three parts: program, administrative and capital.

ADMINISTRATIVE: Salaries and benefits, as well as all other costs to operate the district office and each school's main office and the Board of Education.

PROGRAM: Funding for all K-12 educational programs, including teacher and support staff salaries and benefits, BOCES special education and instructional services, interscholastic athletics and transportation.

CAPITAL: Includes debt service on buildings, school bus purchases, salaries and benefits of all custodial staff, and all building operation expenses.

VOTER QUALIFICATIONS Individuals are eligible to vote if they are a U.S. citizen, at least 18 years old and a resident of the school district for at least 30 days prior to the vote. Voter qualifications are mandated in accordance with New York State Education Law. *NOTE:* Voting inspectors reserve the right to check the driver's license of any voter to verify residency.

BALLOTS Qualified voters may apply for an absentee ballot or a military ballot. New this year, qualified voters are also allowed to vote early. Early ballot voting is available due to the new Early Mail Voter Act, effective January 1, 2024. Early voting is possible without any reasons needed for voting early. Similar to absentee ballot voting, you must fill out an application to vote early. There are separate applications for early voting or absentee ballot voting, but the application process and deadlines are the same for both.

All ballot applications are available online and at the SCCS District Office: 2384 State Route 34B, Aurora, NY 13026. Applications must be received at the SCCS District Office by 4pm on May 14, 2024 if the ballot is to be mailed or 4pm on May 20, 2024 if you plan to pick up your ballot.

The completed ballot must be received by 5pm on May 21, 2024.

VOTERS TO DECIDE ON FOUR PROPOSITIONS AND TWO BOARD OF EDUCATION CANDIDATES

1.) PROPOSITION for 2024/25 PROPOSED BUDGET

Shall the following resolution be adopted, to-wit: RESOLVED that the Board of Education of the Southern Cayuga Central School District, Counties of Cayuga and Tompkins, New York, be and hereby is authorized to expend the sum of \$19,914,840; and levy the necessary tax therefore for the 2024/2025 school year?

2.) PROPOSITION for the PURCHASE OF STUDENT TRANSPORTATION VEHICLES in 2024/25 Shall the following resolution be adopted, to wit: RESOLVED, that the Board of Education of the Southern Cayuga Central School District, Cayuga and Tompkins Counties, New York, is hereby authorized to purchase student transportation vehicles including incidental equipment and expenses in connection therewith, at an aggregate maximum estimated cost not to exceed \$309,568 therefor, and that \$309,568 or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District shall be issued?

3.) PROPOSITION to FUND AURORA FREE LIBRARY

Shall the Southern Cayuga Central School District levy and collect a tax separate and apart from the annual school district budget, pursuant to Section 259 of the Education Law of the State of New York, in the sum of \$85,000 (which is an increase of \$5,000 from the levy in effect from 2023-2024 in the sum of \$80,000) for the continuing support and maintenance of the Aurora Free Library, with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Southern Cayuga Central School District?

4.) PROPOSITION to FUND HAZARD LIBRARY ASSOCIATION

Shall the Southern Cayuga Central School District levy and collect a tax separate and apart from the annual school district budget, pursuant to Section 259 of the Education Law of the State of New York, in the sum of \$61,825 (which is an increase of \$5,000 from the levy in effect from 2023-2024 in the sum of \$56,825) for the continuing support and maintenance of the Hazard Library Association, with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Southern Cayuga Central School District?

*Pursuant to Section 2023 of the Education Law, if the proposed budget is defeated in May, the SCCS Board of Education can put another budget, the same or revised, up for vote in June or immediately adopt a contingent budget. After two unsuccessful votes, the district must adopt a contingent budget. Contingency would mean further reducing the proposed by

\$185,105, resulting in additional reductions for programs and services.

STUDENT TRANSPORTATION VEHICLES


On May 21, voters will be asked to consider a proposition for the purchase of school buses and a vehicle to transport students. If approved, the district will borrow \$264,567 to purchase (1) new 28 passenger wheelchair school bus, (1) 66-passenger school bus, and (1) mini-van/SUV for student transport. The original purchase price is \$309,567 but we will utilize trade-in discounts for the older higher mileage buses to reduce the costs. The bus purchase is also eligible for approximately \$147,630 in state aid, which is more than half of the purchase price. This cost is calculated in the debt service for 2024/25, so it does not increase the proposed budget.

These purchases are part of our on-going 5-year bus replacement plan to preserve the resale value of bus trade-ins and provide coverage under a 5-year/150,000-mile warranty for parts and service, reducing expenses.
